**Applications and all accompanying documents must be received by the close of business (4:00 p.m. PST) on the closing date of the announcement.**

**INDIAN PREFERENCE POLICY:** Preference in filling vacancies is given to qualified Indian candidates in accordance with the Indian Preference Act of 1934 (Title 25, USC, Section 472). Verification Form BIA-4432 must be submitted with the application if claiming Indian Preference. Indian preference eligible that are not currently employed in the Federal Service will be appointed under the Excepted Service Appointment Authority (Schedule A). Consideration will be given to Non-Indian applicants (status or reinstatable) in the absence of qualified Indian Preference eligible.

**EQUAL OPPORTUNITY EMPLOYER:** Within the scope of Indian preference, all candidates will receive consideration without regard to race, color, sex, age, religion, sexual orientation, national origin or other non-merit factors.

**REASONABLE ACCOMMODATION LANGUAGE:** This agency provides reasonable accommodation to applicants with disabilities. If you need reasonable accommodation for any part of the application and hiring process, please notify this agency. The decision in granting reasonable accommodation will be on a case-by-case basis.

**VETERANS EMPLOYMENT OPPORTUNITIES ACT:** Veterans who are preference eligible or who have been separated from the armed forces under honorable conditions after 3 years or more of continuous active service may apply.

**STATEMENT OF DUTIES:**

Residential Life Manager will supervise Home Living Assistants and assist the Home Living Specialist in maintaining the day to day supervision, counseling, health and welfare of students living in the dormitories. The Residential Life Manager manages the day to day, 24 hour operation of one or more dormitories, supervising 9-15 Home Living Assistants, assuring that the goals of the home living program are carried out in his/her assigned dormitories. Implements a program that permits and encourages students in decision-making and responsibility for their actions and conduct. Ensures that general housekeeping and cleaning tasks are carried out and surrounding grounds are cared for. Orients new employees to school policies and prescribed routines, inspects areas regularly to see that acceptable standards are maintained. Conducts performance ratings for Home Living Assistants. Confers with union steward on employee grievances. Assures that students are properly oriented and aware of student rights, responsibilities, drug and alcohol abuse programs, pass privileges, special school programs, leave, curfew, etc. Maintains discipline, observes and reports on attitudes and behavior. Handles student disciplinary and counseling problems independently and as brought to his/her attention by other staff members.

Performs tours and inspections of dormitories that housekeeping standards are being met. Drives a government vehicle as required.

**BASIC EDUCATION AND EXPERIENCE REQUIREMENTS**

High school diploma or GED and an Associate's Degree (or higher) in applicable discipline from an accredited institution of higher education or completion of 60 semester hours of study in applicable discipline from an accredited institution of higher education. 1 year of residential life/home living related work experience. Qualifying experience should be in the same line of work or similar job working with school children.

**BASIS OF RATING:** All applicants for this position will be rated and ranked based upon the extent and quality of their experience, training and/or education as reflected on the application. Applicants will be further evaluated according to the degree to which they possess or have the potential to acquire knowledge, skills, abilities, and personal characteristics as listed below. The judgment of qualifications will be based on the material submitted; therefore, it is to the applicant's advantage to give complete and thorough responses and to present information in a neat and orderly fashion. Qualifications and veteran's preference eligibility will be determined on the basis of information submitted.

**CONDITION OF EMPLOYMENT:**

Position requires operation of a motor vehicle in performance of duties; a valid State Driver License is a prerequisite. A valid State Driver license must be maintained as a condition of employment; failure to do so may result in removal from the position.

**SUITABILITY & CLEARANCE REQUIREMENTS:**

A background security investigation is required. Appointment is subject to the successful completion of the security investigation and favorable adjudication. Failure to meet these requirements will be grounds for termination.

**PHYSICAL REQUIREMENTS:**

Good distant vision in one eye and ability to read without strain printed material the size of typewritten characters are required, glasses permitted. Ability to hear the conversational voice, with or without a hearing aid, is required; in most instances and, amputation of arm, hand, leg or foot will not disqualify an applicant for appointment, although it may be necessary that this condition be compensated by satisfactory prosthesis. In addition applicant must possess mental and emotional stability.

**SPECIAL REFERENCE:**

- You must be a U.S. citizen to qualify for this position.
- Applicant is subject to a favorable background investigation. Upon selection, selectee will be required to complete a Declaration for Federal Employment, OF-306. This is a Non-Critical, Moderate Risk Position subject to a favorable adjudicated background investigation.
- Appointment is subject to probationary period for three full consecutive contract years.
- The incumbent is required to drive a motor vehicle to conduct business at field locations. A valid State driver's license is required. All applicants **MUST** submit a current GSA Form 3607,

Motor Vehicle Operator's License and Driving Record in order to receive consideration. Incumbent must possess a valid State Driver's License.

**Notification Requirements**

Section 231 of the Crime Control Act of 1990, Public Law 101-647 (codified in 42 United States Code § 13041), requires that employment applications for Federal child care positions have applicants sign a receipt of notice that a criminal record check will be conducted as a condition of employment.
